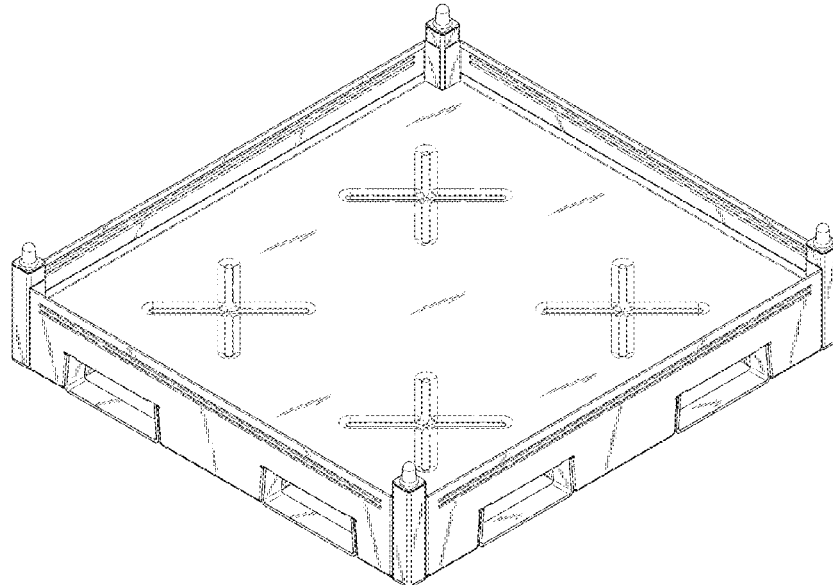
(57) **CLAIM**

The ornamental design for a pallet, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevated perspective view of a pallet showing Applicant's invention.  
 FIG. 2 is a depressed perspective view of the pallet of FIG. 1.  
 FIG. 3 is a top plan view of the pallet of FIG. 1.  
 FIG. 4 is front side elevational view of the pallet of FIG. 1, the back side being a mirror image thereof.  
 FIG. 5 is bottom plan view of the pallet of FIG. 1; and,  
 FIG. 6 is a left side elevational view of the pallet of FIG. 1, the right side being a mirror image thereof.  
 The broken lines in FIGS. 1-3 and 5 depict portions of the pallet that form no part of the claimed design.

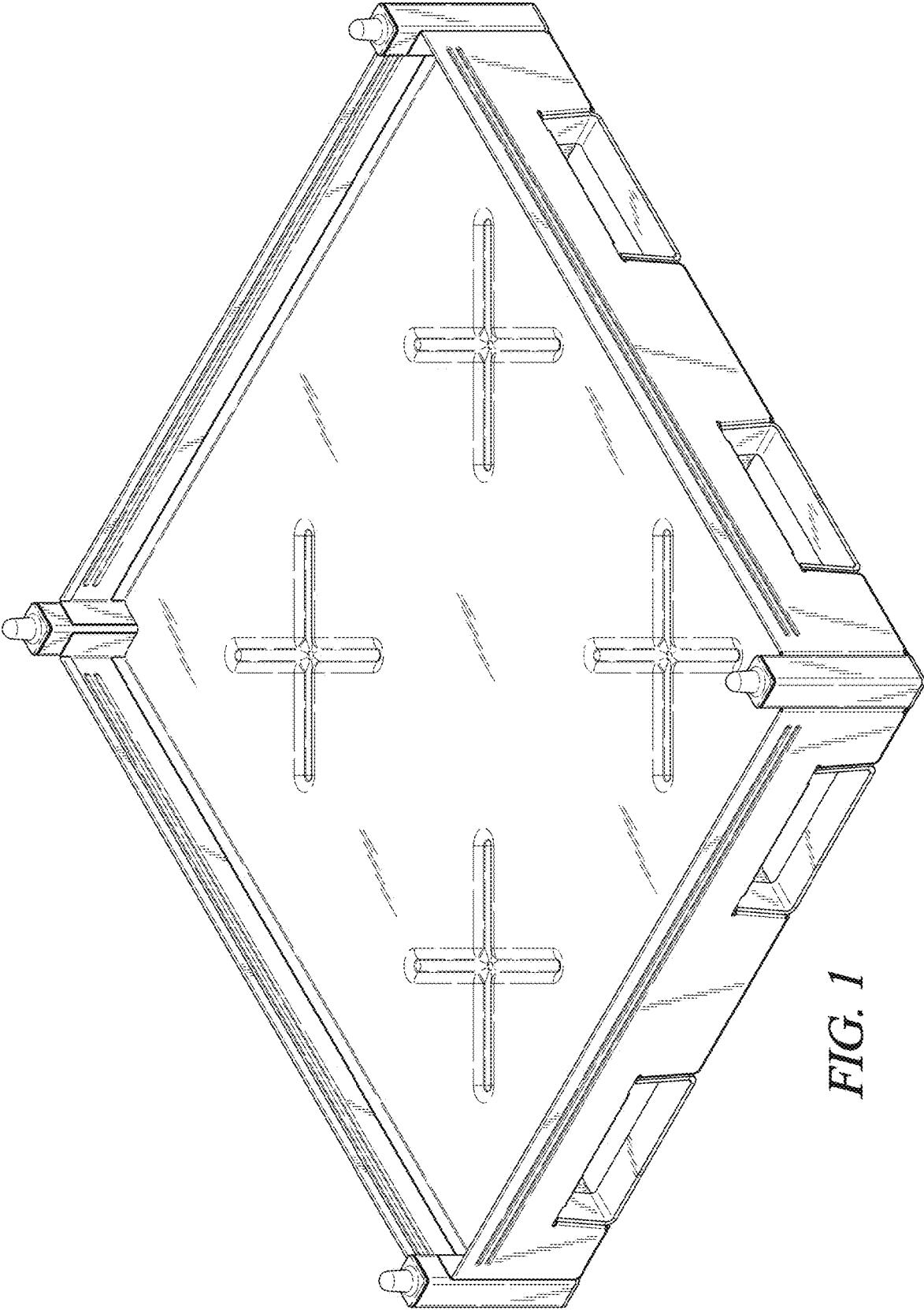

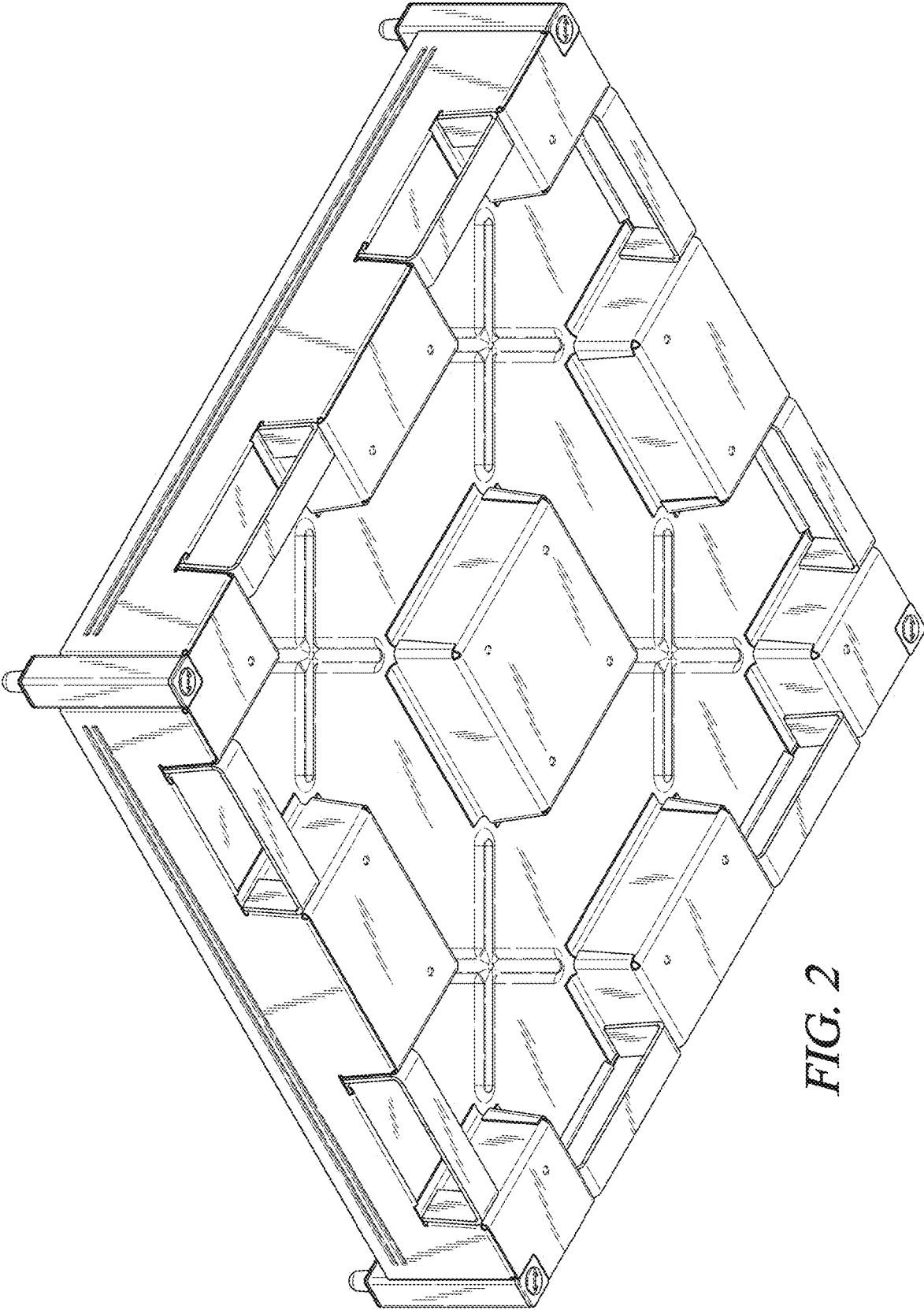
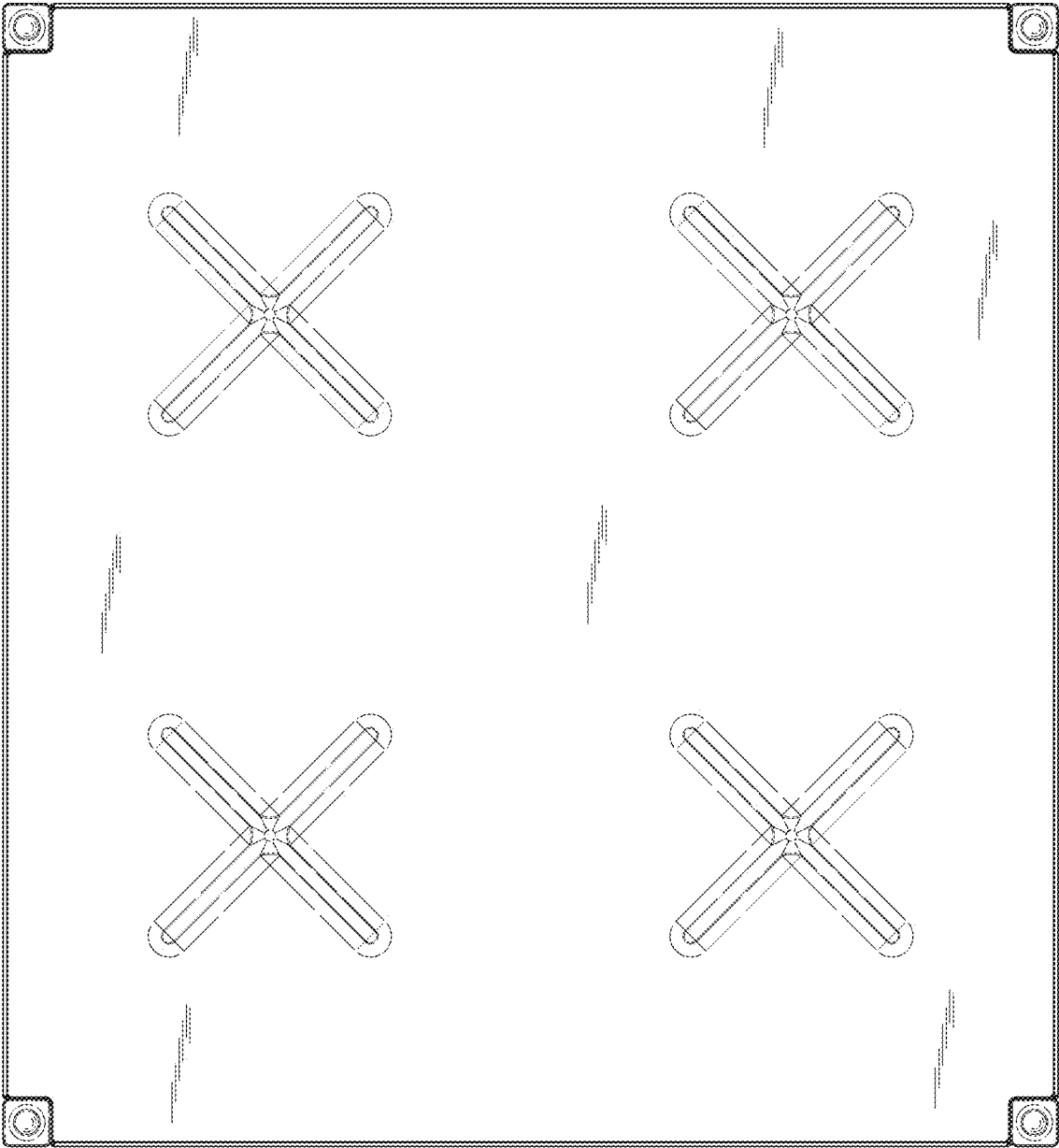
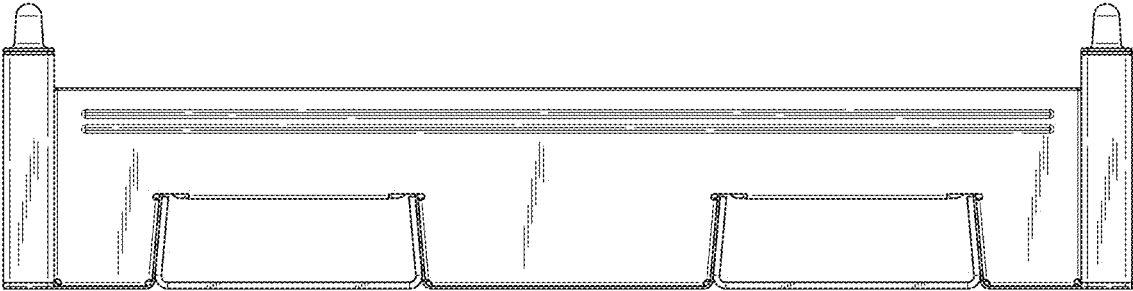


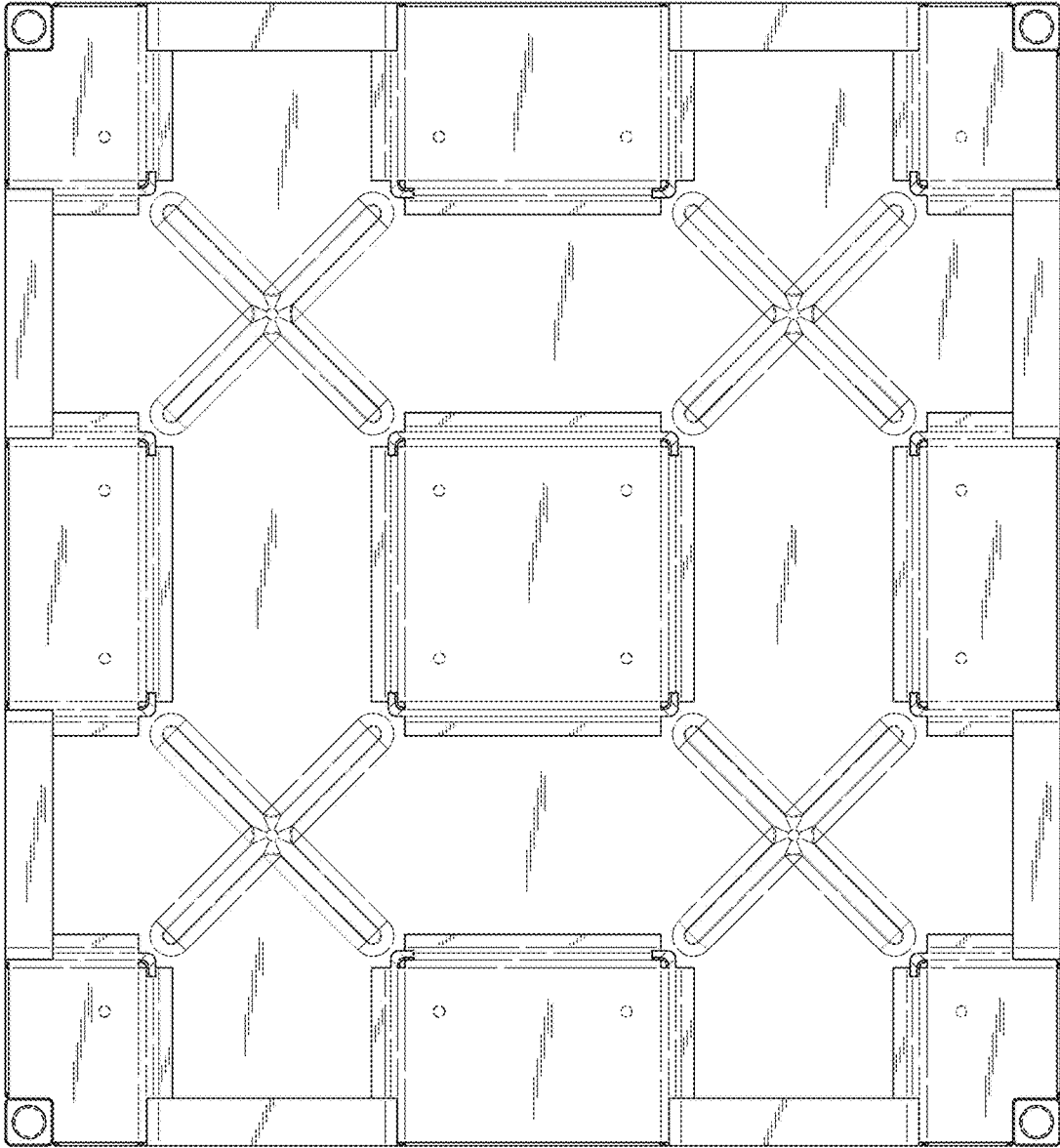

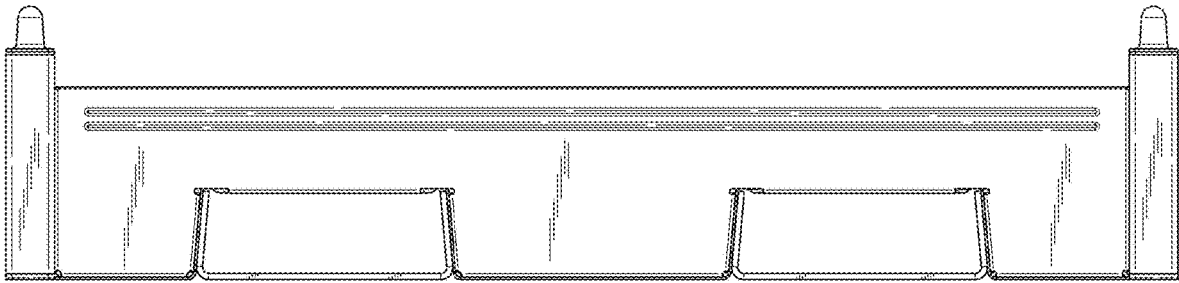
